After you complete your DS-260 (s), you and each family member immigrating with you MUST collect the civil documents required to support your visa application. Your civil documents MUST be issued by the official issuing authority in your country. Please refer to the Document Finder to learn about the civil document requirements for each country.

Civil Documents - Travel
Submitting Form DS-260 does not formally execute a visa application. The visa application is not formally made until the visa applicant (s) is interviewed by a U.S. consular officer. After submitting Form DS-260 online, you must print the confirmation page and bring it to your interview. You can print this from CEAC any time after you complete your DS-260 application.

Online Application - Travel
On the case summary screen, click on “Start now” for the visa applicant whose documents you want to upload. You will be taken to a screen with a list of required documents and, below that, an area for optional documents. Scan and upload your civil documents here.

Civil Documents FAQs - Travel
Applicants in the IR-5 (Parent of a U.S. Citizen who is at least 21 years old) and F4 (Brothers and sisters of United States Citizens) visa categories must submit: An original or certified copy of their Petitioner’s birth certificate.

To submit documents, log into CEAC and go to the “Start Now” buttons located under Affidavit of Support Documents and Civil Documents. When you have uploaded all the required documents for each section, press “Submit Documents”.

I-910, Application for Civil Surgeon Designation Use this form to apply for civil surgeon designation. You do not need to apply for civil surgeon designation if you fall under the limited blanket designations for military physicians and state and local health departments.

Application for Civil Surgeon Designation | USCIS
Having gone through step 1 (choosing an agent), step 2 (Paying fees), you will be required to submit a visa application form alongside some documents to the National Visa Center (NVC). Each qualified family member immigrating with you must complete the Application for Immigrant Visa and Alien Registration (Form DS-260) via the CEAC.

1 Who can submit a visa application?
You will not be able to upload any civil documents for a visa applicant until he/she has submitted the immigrant visa application. It will say N/A (not applicable) in the Civil Documents column until the Form DS-260 immigrant visa application is completed on CEAC. If you started uploading documents but did not finish, it will say Incomplete.

HOW TO UPLOAD DOCUMENTS TO CEAC
Scan and save your financial forms and evidence, supporting civil documents, and translations as a PDF file. Then send them to NVCElectronic@state.gov as attachments to an email. Please type your case number in the subject line of the email. You can attach multiple PDFs to a single email, but each PDF can be no more than 5 MB (megabytes) in size.

Netherlands Visa: Types, Requirements, Application ...
In principle, processing of the visa application takes around 1 week from the date of submission (excluding Saturdays, Sundays and Holidays announced by the Consulate-General of Japan in Hong Kong). Please note that it is possible that a visa may not be issued even though all the necessary documents are submitted.

1 Who can submit a visa application?
Family members must complete their own application forms. However, you may submit your applications together online or at a Visa Application Centre (VAC) and use one payment receipt for the total amount. Your spouse or common-law partner and children must meet all of the requirements for temporary residence in Canada.
